3. A National Merit Ranking (All India Rank) has been arrived based on the NTA Score.
4. Candidates having same Score are listed in a chronological (ascending) order as per their date of birth.
5. Candidates having same score have been given the same Merit, and the next Merit rank has been increased by the same number i.e. if there are two candidates at Merit2, Merit 3 would not be awarded to the next candidate but Merit 4 would be given.
6. The admission authorities are advised to use NTA score awarded to the students for allotment of seat in the AICTE approved programs along with the other criteria that may exist, as applicable.
7. Candidate's particulars including Category and Person with Disability (PwD) have been indicated as mentioned by the candidate in the online Application Form.
